Concord is a year-round festival destination

At the start of this new year, it's exciting to look back and see how Concord has grown during 2023—not only by adding new businesses to the downtown landscape and beyond, but as a destination for travelers. Many of the large events and festivals that hibernated during the COVID-19 pandemic have come back with greater force, attracting thousands of people to our vibrant city. We're proud to see so many of our members participating in our city's evolution as a festival and event destination, and are excited to share some of Concord's biggest calendar items for 2024.

Concord's Main Street is one of the most exciting locations to see festivals take place. With our pedestrian-friendly sidewalks, beautiful landscaping, sculptures, and vibrant small business community, the environment is perfect for a celebratory event, and is sure to encourage visitors to return for further exploration of the shopping and restaurant options in our downtown area. Concord's signature Main Street event is Market Days, hosted by Intown Concord June 20-22. This year's event celebrates the festival's 50th anniversary, and is anticipated to attract 50,000 attendees. In addition, a new event— New Hampshire Book Festival—is coming to Concord October 4-5, and a re-envisioned Capital Arts Fest, an immersive music and arts festival is tentatively planned by our Creative Concord committee for October 18-19.

Many of our biggest events highlight important causes and the work of local or statewide nonprofits, reflecting our city's community-minded nature. The State House Lawn is the starting location for many walks and races such as the Rock N' Race to benefit Concord Hospital Payson Center for Cancer Care on May 8, Best Buddies

Friendship Walk on May 11, 10th Annual Walk a Mile in Their Shoes event in support of the Thrive Survivor Support Center (formerly the Crisis Center of Central New Hampshire) on October 2, and much more.

Moving away from downtown, Everett Arena offers 18,000 square feet of exhibit space during the spring and summer months when ice skating season has ended. This building is operated by the City of Concord's General Services Department, and hosts a wide variety of events and shows, including a brew festival, antique show, bridal show, gem and mineral show, and more. Mark your calendar for Castleberry Fair's Capital City Craft Festival April 6-7 at the Everett Arena.

Concord is full of beautiful locations to host unique events. A community favorite is the Concord Multicultural Festival, happening on September 22 at Keach Park. The Black Ice Pond Hockey Tournament transforms White Park into multiple ice rinks January 26-28. And McAuliffe-Shepard Discovery Center will host a special countdown to the solar eclipse on April 8.

Whether you're looking for a family-friendly event, music festival, or race to support a great cause, our city's growing event schedule has something for everyone. The Chamber hosts a robust event calendar, where all members of the community can submit their offerings. 



BUSINESS FOCUS: Operating agreements for NH multi-member LLCs

Guidelines for structuring and formatting

- have been drafting operating agreements for members of New Hampshire multi-member LLCs since 1993, when the New Hampshire LLC Act was first enacted. In addition, in 1998, a global legal and medical publisher called Wolters Kluwer published the first draft of my book entitled "Drafting Limited Liability Company Operating Agreements," and I have updated that book at least once a year ever since. On the basis of this experience, I suggest, for New Hampshire business lawyers, the following structural and formatting guidelines for the drafting of operating agreements for members of New Hampshire multi-member LLCs.
- 1) Title page. To give the operating agreement an appropriate dignity, the agreement should begin with a title page. The identification of the LLC set forth on that page should provide, in the fewest possible words, the maximum possible information about the LLC's legal and tax structure. A hypothetical example follows:

OPERATING AGREEMENT, DATED AS XX, 20XX, OF ABC, LLC


A Three-Member New Hampshire Limited Liability Company with a Limited Partnership Management Structure, Controlled by a Member-Manager and Subject to Federal Taxation as a Partnership

Obviously, the above title may have to be changed to take account of the name of the LLC, its "date as of," its management structure (which, for example, may be

- a general partnership structure, not a limited partnership structure), and its federal tax structure.
- 2) Tables of Contents. Immediately after the title page, the operating agreement should contain two tables of contents. The first should be a one-level table that provides readers with a clear overview of the contents of the agreement. The second should be a two-level table that enables them to find and review specific provisions of the agreement that address issues that concern them.
- Table of Exhibits. Discussions of issues covered by the agreement that are particularly detailed lengthy should generally be relegated to exhibits that follow the agreement text so as not to clutter the text. These exhibits may provide, for example, complex listings of cash and property contributions and the terms governing these contributions, complex LLC allocations and distributions, complex arrangements for capital calls or for protections of items of intellectual property and confidential items that are to receive special treatment by the members. Obviously, all of these tables should be listed in a table of exhibits.
- 4) Date And Members. The first page of the text of the agreement should begin with the name of the LLC as stated in the title page. It should then, under appropriate captions, identify the "date as of" of the operating agreement and the LLC's members residential or business addresses.

5) Background Statements.

In many operating agreements for multimember



LLCs, it is useful to include, after the listing of members, statements of background that will provide readers with a context for understanding the provisions in the Agreement. These may include, for example, statements as to the intended date and the reason for the formation of the LLC, the LLC's purpose, and identifications of significant LLC agreements with third parties relevant to the agreement.

6) Provisions. The provisions in the text of the agreement should be written in plain English, and they should, to the extent possible, be understandable by non-lawyers on a careful first reading. Finally, the provisions of the agreement should contain no run-on sentences or paragraphs.

BUSINESS FOCUS: Nature connections for better work-life balance

Welcome to 2024. For many of us, January brings feelings of overwhelm and stress, affecting our personal and work lives. The holidays, which provided great diversions, are behind us, those New Year's resolutions are now clamoring for attention, and the looming frigid winter months can exacerbate the "Winter Blues" or Seasonal Affective Disorder (SAD, an appropriate acronym).

Recognizing and understanding how our stress mechanisms operate provides valuable information to consciously make changes and adopt effective strategies to improve our wellbeing. As we evolved over millions of years, our primitive danger detection system, the Limbic System, kept us safe with bursts of stress hormones like adrenaline and cortisol to propel us into life-saving action. Unfortunately, this fight-flight-freeze response, designed for acute and timelimited situations, has difficulty shutting off and now operates continuously, keeping many of us in a chronic state of physiological and emotional stress.

Living in this beautiful state of New Hampshire, we have an excellent tool to manage daily stress: Our natural environment. Yes, the mountains, lakes and beaches are the obvious stars of the fantastic options available to foster connections with nature. However, studies (NIH, National Library of Medicine, 2021) conclude that even a few minutes of mindfully embracing aspects of our natural environment create benefits such as: A decrease in stress hormones, a decrease in blood pressure, an increase in immune function, and an increase in energy, focus and general feelings of wellbeing.

Collecting information through our five senses enables us to easily create new memories and experiences that we can use to manage stress. Here are simple and effective techniques we can incorporate into our existing daily routines.

Sense of Sight

Intentionally notice the natural elements in your surroundings, especially walking into work, running errands, or even gazing out windows. Look at the shapes and colors of the trees. Glance up at the sky and study the clouds for a moment. While walking, become aware of nature in your neighborhood. Even the snowbanks offer visual benefits! Bring houseplants or pictures of the natural world into your home and workspace.

Sense of Hearing

Take advantage of the 360 degrees of sound available to your ears, enjoying birdsong, wind rustling in the trees, and children playing. Bundle up after dark and listen for the hoot of courting owls this month. Close your eyes and deepen the experience, triangulating the sound's location.

Sense of Smell

Remember the smells of freshly cut grass, salty air, the clean smell after a summer rain shower? Frosty and crisp air can smell invigorating, too! Create new memories to savor using drops of essential oils on cotton balls, sealing them into baggies, and poking a few holes with a toothpick for scent access. Peppermint, lavender, balsam, and vanilla are great options.

Sense of Touch

Head outside and connect your fingers to the cool, smooth bark of deciduous

trees or the rough texture of pines. Make a snowball with your bare hands! The textures of



indoor plants provide opportunities to connect with nature in the winter.

Sense of Taste

Create opportunities to slow down and savor meals, focusing on textures and tastes. Silence phones and set aside devices while nourishing your body, embracing these mindful moments.

Incorporating these sensory strategies into your daily routine will help manage stress and improve your overall wellbeing, bringing a better work-life balance. Here's to a great 2024!
